Councillors Resolved NEUTRAL to this planning application with the following comments:

- The Parish Council agrees that improvements to the cottage to make it more comfortable as a modern home is completely understandable and acceptable.
- However, the grade II listed cottage is set in the conservation village on the village green and therefore needs to be sympathetic with the nearby dwellings. We are concerned about the dark stain of the timber boarding and the modern glass front door arrangement. Perhaps the door could be round the side.
- The appearance of the rear extension is not critical as it cannot be seen from the road/green but the side extension needs to enhance and not dominate the original house.
- There is some confusion as to the window/door material. The design and access statement suggests possibility of grey UPVC or aluminium whilst the application form suggests timber or aluminium. UPVC has previously been restricted on planning applications within the conservation area, so would require careful consideration if this is the chosen material.
